## NIAGARA TENPIN BOWLING ASSOCIATION TOURNAMENT RULES

1. C.T.F. Sanctioned Tournament. All C.T.F. rules will govern this tournament.
2. Open to all bowlers 18 years of age and older who are members of the Niagara Tenpin Bowling Association.
3. **TOTAL ENTRY FEE MUST BE REMITTED WITH THE ENTRY FORM TO HAVE THE ENTRY ACCEPTED.** No Postdated cheques; Returned cheques subject to prevailing bank service charge.
4. **Entries close 30 minutes prior to the start of each squad, no late entries accepted.** As squad sizes are limited dependant on the event, entries shall be recognized according to time of receipt of entry. **Advance entries are only deemed complete if accompanied by full payment.**
5. Bowlers arriving late for their assigned shift will start in the frame being bowled and zero shall be scored for each frame missed.
6. Entrants will use their highest 2016/2017 NTBA sanctioned C.T.F. average based on 21 games or more. If no NTBA C.T.F. average for the 2016/2017 season the bowler will use his/hers highest NTBA C.T.F. sanctioned average based on 21 games or more as of February 10, 2018. Proof of average to be supplied by bowler submitting current average. All others will use C.T.F rule 319-B.
7. Handicap shall be 100% of the difference of the bowlers average and 220.
8. Bowlers will bowl 4 games per event on the same pair of lanes.
9. It shall be the bowlers responsibility to verify their highest NTBA C.T.F. sanctioned average. Refer to C.T.F. rule 319a-3 for specific details.
10. C.T.F. RULE 319a-2 THE TEN PIN RULE and RULE 319-D & 319-E shall not apply. (refer to [www.gotenpinbowling.ca](http://www.gotenpinbowling.ca))
11. Bowlers entering All-Events must indicate such on completed entry form for singles and doubles events, prior to bowling the singles event. Bowlers may only cash once in All-Events, first series in each event bowled to be used. SENIORS ALL-EVENTS OPTIONAL; Open to bowlers age 50 or older. Seniors may enter all divisions of All-Events at a cost of \$5.00 per division.
12. Bowlers may enter multiple squads of the doubles event with the same team, but will cash their highest score only. C.T.F. Rule 317 2(b). (refer to [www.gotenpinbowling.ca](http://www.gotenpinbowling.ca))
13. All prize money won will be paid to the team captain or the person who has signed the entry form. That person must distribute the prize money to all bowlers concerned within 30 days of receiving a cheque from the Tournament Director. Cheques not cashed within 90 days of issue become invalid.
14. No substitutes allowed during the game. Emergency cases will be decided by the Tournament Director.
15. Team Captains or their representatives must report to the tournament office **1/2 hour prior to squad time** for registration and any changes in their lineups.
16. All protests must be in writing prior to the time the prize money is paid out which is 30 days after the tournament is completed.
17. PRIZE RATIO: All prize money returned 100%. Handicap Scores = At least 1 in 7 to cash in doubles and singles. 1st Place High Scratch score will receive \$35.00 per member in doubles and singles. 1 in 10 to cash in All-Events, Scratch and Handicap prize fund determined by the number of entries in each category.
18. Use of banned cleaning substances (C.T.F. rule 331) shall result in the disqualification of scores bowled.
